Create

- Create a structure that allows the CoD to operate at optimum levels.
- 2. Create an environment within the County that is fully inclusive and accessible.
- Create opportunities for the disabled community to participate and influence public policy within the County.
- 4. Create a dialogue with leaders within the County to increase greater awareness of issues impacting the disabled community in San Mateo County.

Educate

- 1. Educate ourselves as to the issues and concerns of the disabled community.
- 2. Educate the County and general public regarding the issues and concerns of the disabled community.

Accessible County Facilities & Programs

- Working on updating San Mateo County's ADA Transition Plan:
- The County made a significant investment (approx. \$500,000) in 2018 to have Disability Access Consultants update the County's ADA Transition Plan which included 81 facilities and 160 miles of public sidewalks in unicorporated San Mateo County.
- The County recently surveyed the public and county staff as a method to collect input for the Transition Plan

2021-2022 Updates

Summary of Work Year-to-Date

- June 2021 January 2022 ADA Staff and Public Surveys were revised by the committee and distributed through Risk Management to help advise the Transition Plan
- October 2021 Site visit was conducted by the committee for Memorial Park facilities renovations, including three new restroom renovations by the Parks Department
- February March 2022 Committee provided input to DPW for Safe Harbor Shelter site concept to improve accessibility

2021-2022 Updates

Summary of Work Year-to-Date

- August 2022 Committee began preparations for establishing a county-wide priority list for barrier removal
- September 2022 Committee recommended that "Our Place" and "Pal Care" childcare centers be added to the CIP



Committee Goals

- 1. Advise the County's Commission on Disabilities and the Board of Supervisors on the accessibility needs of County-owned, or leased property and facilities.
- 2. Work with all the departments within the County to assure equal public access to facilities and programs as defined by the Americans with Disabilities Act (ADA).
- 3. Work to monitor and update the Transition Plan
- 4. Help educate County employees about the ADA.

Committee Objectives

- Continue partnering with the various County divisions in removing barriers throughout the County, these divisions include but are not limited to:
 - Department of Public Works
 - 2. Health System
 - Human Services
 - 4. Elections Office
 - 5. County Executive Office (including Chief Equity Officer)
 - 6. County Parks
- Establish a countywide priority list for removal of barriers
- Continue to advocate for a full-time Title II coordinator position moving forward

Legislation Advocacy Outreach

Hate Crimes & Abuse Against People with Disabilities

2021-2022 Updates:

- Abuse Roundtable Group, created in 2019 to address abuse against individuals with disabilities, established a workgroup to explore creating a statewide Caregiver Abuse Registry
- Workgroup includes representatives from the CoD, Disability Rights California (DRC), regional centers, Aging and Adult Services, State Independent Living Council, State Council on Developmental Disabilities, Public Authority Advisory Committee, California Department of Social Services/APS, CID, and other offices. Workgroup participants are an advisory group for DRC
- DRC would be the lead sponsor if a proposal is created and are looking for a co-sponsor.
- Workgroup has met 7 times since Dec. 2021 and anticipates another year of exploratory work on this issue before reaching a proposal stage

Legislation Advocacy Outreach

Committee Goals

- 1. Empower the disabled community through first responder training, supporting victims and allies in reporting abuse, & continuing to educate direct service providers about signs of abuse and mandated reporting.
- 2. Continue to advocate for programs and policies that increase safety for individuals with disabilities.

Legislation Advocacy Outreach

Committee Objectives

- Coordinate Monthly Presentations at CoD General Meetings
- 2. Continue to identify gaps in services for the disabled community
- Continue monitoring and advocating for legislation impacting the disabled community
- 4. Collaborate with members of the Abuse Roundtable Group to create a statewide caregiver abuse registry

2021-2022 Updates

- The Youth and Family Committee, along with several Transition Coordinators from various school districts planned and hosted a series of virtual webinars
- Each webinar discussed the important topics students transitioning out of high school must learn about, such as housing, higher education, and employment
- Webinars held on November 4th, December 2nd, February 28th
- The CoD reassumed its leadership role as the coordinator of the Transition to Independence Fair
